Letter from Community State Bank pertaining to Bank offering its services for collecting property taxes was read by clerk. Any action on acceptance tabled until further investigation by Treasurer Klein. Several other Communications were read and discussed.

Clayton Klein present for more discussion on his desire to purchase Township property adjacent to his property on Gregory Road. Communication with the State Cemetery Commission indicated it was permissible to transfer Cemetery to a private owner. Further action tabled until investigation if property must be advertised for bids before being sold.

## SPECIAL MEETING

FEBRUARY 2, 1977

TIME 8:00 P.M.

A Special informative meeting with the Township Board, Members of the Livingston County Road Commission, and Residents and property owners of Sober Road between Owosso Road and Marsh Road, was held at the Township Hall, to air problems of Sober Road repairs and/or construction.

Supervisor Kingsley called the meeting to order with all Township Board members present. Representing the Livingston County Road Commission were Glen Hanson and Mike Hill members of the Road Commission Board, Don Hallowell, Road Commission Superintendent and Harold Jensen, County Engineer. Also present, County Commissioner Fred Dillingham and several interested Residents and property owners.

Introduction of Township Board and Road Commission representatives by Supervisor Kingsley, and a review of groundwork concerning Sober Road by Kingsley.

Glen Hanson presented information pertaining to construction of roads. State requires 28 foot roadway plus 4 foot shoulder and ditches each side and necessary right of way. Present Sober Road width is 20 feet with little or no ditches. Construction would require much grading and tree cutting.

Superintendent Hallowell reported that three proposals had been submitted. Total construction of one and one half miles estimated at \$65,000.00; total construction of one mile \$43,000.00; construction of one half mile plus graveling of one fourth mile \$30,000.00. Road maintenance of gravel and needed culverts, no estimate.

Meeting opened to question and answer period. Much discussion on costs, procedures, and desires of residents. Majority of residents present indicated their only desire was being able to travel the road under normal conditions. Further action to be negotiated between Township Board and Livingston County Road Commission.

Meeting adjourned by Supervisor Kingsley.
