Inspection fees of \$500.00 shall be paid to Conway Township upon the filing of the application for a private road, and a \$50.00 application fee, to be held in Escrow by the Township of Conway. Any inspection monies left after completion of the road shall be returned to the developer, and any costs over the Escrow amount shall be reimbursed to Conway Township by the developer.
