- **11.** If Applicant is seeking approval of a commercial solar energy collector, Applicant must provide a copy of this Application and all required attachments to the Fire Chief of the Fowlerville Area Fire Department (FAFD) for review and approval. In addition, Applicant must include the following with this Application, which are also to be provided to the FAFD:
 - An operations agreement, which sets forth the operation parameters, the name and contact information of the certified operator, inspection protocol, emergency procedures, and general safety documentation.
 - A site plan showing property lines and physical features of the site, including roads; proposed changes
 to the landscape, grading vegetation clearing and planting, exterior lighting, screening vegetation, and
 structures; distance between proposed solar collector and all property lines and existing on-site
 buildings and structures; and the height of all structures.

- The site plan shall also include information on where and how the solar farm will connect to the power grid. No solar farm shall be installed until evidence has been given to the planningcommission that the electric company has agreed to allow the applicant to install an interconnected customer-owned generator to the grid or the Applicant otherwise has a means for the wholesale or retail sale of generated electricity.
- Financial security guaranteeing removal of the system must be posted at the time of receiving a construction permit for the system. The security shall be in the form of a cash bond, irrevocable bank letter of credit, or performance bond in a form approved by the Township. The amount of suchguarantee shall be no less than the estimated cost of removal and may include a provision for inflationary cost adjustments. The estimate shall be prepared by the engineer for the Applicant andshall be subject to the approval by the Township.

SPECIAL USE PERMIT IS NON TRANSFERABLE AND WILL BE ISSUED IN THE NAME OF THE APPLICANT.
